## Summary of Palm Beach County Commission on Ethics Meeting Held on March 5, 2020.

The Palm Beach County Commission on Ethics (COE) took the following actions at its monthly public meeting held on March 5, 2020.

Michael H. Kugler and Carol E. A. DeGraffenreidt were sworn in as COE Commissioners by Judge Sarah Shullman. Commissioner Kugler was appointed by the F. Malcolm Cunningham, Sr. Bar Association, the Hispanic Bar Association of Palm Beach County, and the Palm Beach County Bar Association. Commissioner DeGraffenreidt was appointed by the Palm Beach County Association of Chiefs of Police.

Commissioner Peter L. Cruise was elected COE Chair, and Commissioner Michael S. Kridel was elected COE Vice Chair.

<u>C19-011</u>: After considering the investigative report, probable cause recommendation, and statement of the COE advocate and respondent, the COE found that probable cause existed, ordered restitution to be paid, and issued a letter of instruction to conclude the matter.
