Conflict of Interest

Dear Sergeant Schaaf,

Your request for an advisory opinion to the Palm Beach County Commission on Ethics (COE) has been received and reviewed. The opinion rendered is as follows:

## QUESTION:

Would it violate the Palm Beach County Code of Ethics (Code) if you serve on the Town of Lantana Police Pension Board when you may vote on items that will affect your pension benefits as a Town of Lantana police officer?

## ANSWER:

The Code prohibits public employees or officials from using their official positions in any way to give a special financial benefit not shared by similarly situated members of the general public to specified persons or entities, including themselves.<sup>1</sup> Further, the Code prohibits officials from participating in or voting on a matter that will result in a special financial benefit being given to any of the persons or entities specified in Section 2-443(a)(1)-(7).<sup>2</sup>

Typically with a question involving a voting conflict, the COE analyzes whether the financial benefit is shared with similarly situated members of the general public and considers the number of persons who stand to gain or lose from the decision.<sup>3</sup> The COE has held where the class of persons who stand to gain from a decision is small, it is more likely that an official will have a conflict.<sup>4</sup> The general line drawn by the Florida Commission on Ethics involves situations where the interest of the public official involves 1% or less of the class, in other words, 100 or more affected persons. Here, the size of the class is small, consisting of 39 members. Your interest in the class is 2.5%, which is above the 1% threshold used by the

COE and the Florida Commission on Ethics. As such, it would appear that you are more likely to have a voting conflict because of the small size of the class.

However, it should be noted that your appointment to the board is required by ordinance and by Florida statutes.<sup>5</sup> Section 185.05, Florida Statutes, requires that membership of the board of trustees of municipal police officers' retirement funds must consist of five members, "two of who must be police officers...who are elected by a majority of the active police officers who are members of [the retirement plan]." The Florida Commission on Ethics has previously opined that at first glance a conflict of interest appears to exists for police officers sitting on retirement boards because Florida Statutes prohibits a public official or employee from having or holding "any employment or contractual relationship that will create a continuing or frequently recurring conflict between his or her private interest and the performance of his or her public duties or that would impede the full and faithful discharge of his or her public duties." However, the Florida Commission then held that Section 112.313(7)(b), Florida Statutes, which states that a "public [official] or employee is not prohibited from practicing in a particular profession or occupation when such practice by persons holding such public office or employment is required or permitted by law or ordinance," negates the apparent conflict of interest for police officers who are required by law or ordinance to serve as board members of the retirement fund.

Here, it initially appears that a voting conflict may exist for you because you would vote on a matter that gives you a financial benefit and the size of the class affected is small. However, the COE agrees the Florida Commission's interpretation and has determined that because your appointment to the pension board is required by ordinance and by state law, you will only have a voting conflict if there are circumstances unique to you as the voting official which would enable you to gain (or lose) more than the other members of the class vested or those who will become vested in the Lantana Police Pension. If such a circumstance arises, you must abstain from both voting and participating in the matter, publicly disclose the nature of the conflict, file a State of Florida Conflict Form (Form 8B), and submit a copy of the conflict form to the COE.<sup>8</sup> However, where a vote by you would affect all members of the class equally, no voting conflict would exist.

# FACTS:

You are a Sergeant of the Road Patrol Division for the Lantana Police Department. You are also an elected member of the Lantana Police Pension Board. As a trustee, you may be called upon to vote on items that affect your pension benefits. You are also a vested member in the pension.

By ordinance, the pension board has five members, consisting of two Lantana police officers who are elected, one former police officer who is vested in the pensions and is appointed, and two members who are appointed by the town. The pension plan currently has 39 vested members. As a pension member, you have a 2.5% interest in the class of pension members.

# **LEGAL BASIS:**

#### Sec. 2-443. Prohibited conduct.

- (a) Misuse of public office or employment. An official or employee shall not use his or her official position or office, or take or fail to take any action, or influence others to take or fail to take any action, in a manner which he or she knows or should know with the exercise of reasonable care will result in a special financial benefit, not shared with similarly situated members of the general public, for any of the following persons or entities:
  - (1) Himself or herself;
- (c) Disclosure of voting conflicts. County and municipal officials as applicable shall abstain from voting and not participate in any matter that will result in a special financial benefit as set forth in subsections (a)(1) through (7) above. The official shall publicly disclose the nature of the conflict and when abstaining from the vote, shall complete and file a State of Florida Commission on Ethics Conflict Form 8B pursuant to the requirements of Florida Statutes, §112.3143. Simultaneously with filing Form 8B, the official shall submit a copy of the completed form to the county commission on ethics. Officials who abstain and disclose a voting conflict as set forth herein, shall not be in violation of subsection (a), provided the official does not otherwise use his or her office to take or fail to take any action, or influence others to take or fail to take any action, in any other manner which he or she knows or should know with the exercise of reasonable care will result in a special financial benefit, not shared with similarly situated members of the general public, as set forth in subsections (a)(1) through (7).

This opinion construes the Palm Beach County Code of Ethics Ordinance and is based upon the facts and circumstances that you have submitted. The COE does not investigate the facts and circumstances submitted but assume they are true for purposes of this advisory opinion. This opinion is not applicable to any conflict under state law. Inquiries regarding possible conflicts under state law should be directed to the State of Florida Commission on Ethics.
