### VI. DISCUSSION ON AMENDING COMMISSION ON ETHICS ORDINANCE REGARDING FICPA AS APPOINTING ENTITIY

Ms. Kelley stated that the Florida Institute of Certified Personal Accountant's (FICPA) that appointed Vice Chair Kridel was no longer an active organization, and a new entity would need to be appointed. She added the following:

- Staff continued to research similar entities that have a finance, accounting, or auditing background that could replace the FICPA. The two entities being considered, were:
  - The Palm Beach Chapter of Association of Certified Fraud Examiners (ACFE); and
  - The Palm Beach Chapter of the Florida Government Finance Officers Association (FGFOA)
- She spoke with the president of the ACFE and the organization was interested in serving as an appointing entity. However, she was in the process of meeting with a representative from FGFOA.
- The COE was asked to submit potential entity suggestions to Ms. Kelley by next week.
- A recommendation for an appointing entity would be submitted next month.
- Vice Chair Kridel's position would remain vacant for a couple of months until a new appointing entity was selected.



Re: RQO 22-004 Voting conflict

Dear Mr. Feldkamp,

Your request for an advisory opinion to the Palm Beach County Commission on Ethics (COE) has been received and reviewed. The opinion rendered is as follows:

#### **QUESTION:**

Does the Palm Beach County Code of Ethics (Code) prohibit you from participating in discussions or voting on matters before the Lake Worth Beach Historic Resources Preservation Board (HRPB) regarding the renovation and new construction at the Gulfstream Hotel?

#### **BRIEF ANSWER:**

You are not prohibited from participating in discussions or voting on these matters because the size of the class affected by this project is large enough.

#### **FACTS:**

You are a member and current Chair of the HRPB. The HRPB's function is to consider historic preservation issues. Issues regarding the renovation and new construction at the landmarked Gulfstream Hotel will be coming before the HRPB. You have no financial or other ties to the developer or anyone else involved with the project. However, you live within 400 feet of the Gulfstream Hotel. You own one unit in a condominium diagonally across the street from the Gulfstream Hotel. A search by COE staff using the Palm Beach County Property Appraiser website revealed that, in addition to your condominium having at least 12 owners, there are also single family homes and four other condominiums in the immediate vicinity of the project comprised of at least 115 property owners.

#### **ANSWER:**

The Code prohibits public officials from using their official position in any manner which would result in a special financial benefit, not shared with similarly situated members of the general public, to certain persons or entities, including to themselves.<sup>1</sup> Similarly, the Code also prohibits public officials from voting on an issue or participating in any matter coming before their board which would result in a special financial benefit to themselves.<sup>2</sup>

Whether a matter rises to the level of a prohibited conflict of interest depends on whether the official will receive any special financial benefit. The COE has previously opined that "financial benefit" constitutes economic gain or loss.<sup>3</sup> In evaluating conflict of interest under the Code, the COE considers the number

of persons who stand to gain or lose financially from a decision and whether the gain or loss is remote and speculative. As the COE has previously opined, there is no bright line in determining the number of individuals who would need to be similarly affected to transform a personal gain into a gain or loss shared with similarly situated members of the general public.<sup>4</sup> Therefore, the determination of whether a measure will result in a financial benefit not shared with similarly situated members of the general public turns on the size of the class of persons who stand to benefit from the measure.<sup>5</sup> Where the size of the class is large, a prohibited financial gain would result only if there are circumstances unique to the official that would enable his or her property to benefit more than the other property owners within the class. However, where the class of persons who stand to gain or lose from a decision is small, it is more likely that an official will have a conflict.<sup>6</sup> The general line drawn by the COE, and by the Florida Commission on Ethics, is that no voting conflict is present in situations where the interest of the public official involves 1% or less of the class, in other words, where 100 or more persons are affected.<sup>7</sup> While the "1% Rule" may be an arbitrary cutoff point, it provides certainty and guidance in an area of the law that otherwise lacks clarity.

Here, the area in the immediate vicinity of the Gulfstream Hotel consists of approximately 115 property owners. Thus, your interest in the area is less than one percent. Further, there is nothing in the facts that currently show that the location of your property provides a unique circumstance wherein your personal gain or loss by this vote would exceed significantly that of other property owners in the immediate vicinity of the Gulfstream Hotel. Therefore, because the economic benefit or loss from the Gulfstream Hotel project affects a class large enough so as to remove any prohibited individual financial benefit, you are not prohibited from voting on or participating in discussions on the renovation and new construction plans for the hotel.

#### **LEGAL BASIS**:

The legal basis for this opinion is found in §2-443(a) and §2-443(c) of the Code: **Sec. 2-443. Prohibited conduct.** 

- (a) **Misuse of public office or employment.** An official or employee shall not use his or her official position or office, or take or fail to take any action, or influence others to take or fail to take any action, in a manner which he or she knows or should know with the exercise of reasonable care will result in a special financial benefit, not shared with similarly situated members of the general public, for any of the following persons or entities:
  - (1) Himself or herself;
- (c) **Disclosure of voting conflicts.** County and municipal officials as applicable shall abstain from voting and not participate in any matter that will result in a special financial benefit as set forth in subsections (a)(1) through (7) above. The official shall publicly disclose the nature of the conflict and when abstaining from the vote, shall complete and file a State of Florida Commission on Ethics Conflict Form 8B pursuant to the requirements of Florida Statutes, §112.3143. Simultaneously with filing Form 8B, the official shall submit a copy of the completed form to the county commission on ethics. Officials who abstain and disclose a voting conflict as set forth herein, shall not be in violation of subsection (a), provided the official does not otherwise use his or her office to take or fail to take any action, or influence others to take or fail to take any action, in any other manner which he or she knows or should know with the exercise of reasonable care will result in a special financial benefit, not shared with similarly situated members of the general public, as set forth in subsections (a)(1) through (7).

This opinion construes the Palm Beach County Code of Ethics Ordinance and is based upon the facts and circumstances that you have submitted. The Palm Beach County Commission on Ethics does not
