In re: Daniel Comerford C24-008

Complainant, Heidi Siegel, filed the above referenced complaint alleging that Respondent, Daniel Comerford, Former Mayor for Jupiter Inlet Colony, used his elected position for personal gain, in violation of Section 2-443(a), Misuse of public office or employment, or Section 2-443(b), Corrupt misuse of official position, of the Palm Beach County Code of Ethics.

Pursuant to Section 2-258(a) of the Palm Beach County Commission on Ethics Ordinance, the Palm Beach County Commission on Ethics is empowered to enforce the Palm Beach County Code of Ethics. On November 6, 2025, the Commission conducted a probable cause hearing. After reviewing the Report of Investigation and the Probable Cause Recommendation and listening to statements by the Advocate, the Commission concluded that probable cause does not exist because there was no evidence that Respondent took any action that violated the Palm Beach County Code of Ethics.

Therefore it is:

ORDERED AND ADJUDGED that the complaint against Respondent, Daniel Comerford, is hereby DISMISSED.

b. C25-007

In Re: Marie Rosner C25-007

Vice Chair Cruise read the following final order into the record:

Complainant, Heidi Siegel, filed the above referenced complaint alleging that Respondent, Marie Rosner, former Commissioner for Jupiter Inlet Colony, used her elected position for personal gain, in violation of Section 2-443(a), Misuse of public office or employment, or Section 2-443(b), Corrupt misuse of official position, of the Palm Beach County Code of Ethics.

Pursuant to Section 2-258(a) of the Palm Beach County Commission on Ethics Ordinance, the Palm Beach County Commission on Ethics is empowered to enforce the Palm Beach County Code of Ethics. ¹ On November 6, 2025, the Commission conducted a probable cause hearing. After reviewing the Report of Investigation and the Probable Cause Recommendation and listening to statements by the Advocate, the Commission concluded that probable cause does not exist because there was no evidence that Respondent took any action that violated the Palm Beach County Code of Ethics.

Therefore it is:

ORDERED AND ADJUDGED that the complaint against Respondent, Marie Rosner, is hereby DISMISSED.

c. C24-018

In re: Barbara King C24-018

Commissioner Vara-Garcia read the following final order into the record:

The above referenced complaint against Respondent, Barbara King, a Commissioner for the City of South Bay, alleged that Respondent used or attempted to use her position in a manner that may have resulted in a special financial benefit to herself or her outside business in violation of Section 2-443(a) of the Palm Beach County Code of Ethics.

Pursuant to Section 2-258(a)¹ of the Palm Beach County Commission on Ethics Ordinance, the COE is empowered to enforce the Palm Beach County Code of Ethics.

At the probable cause hearing, the COE advocate recommended a finding of probable cause, the issuance of a letter of instruction, and dismissal of the complaint. This recommendation is based on the Respondent's statement that she was unaware she should not use her title in matters related to City business.

Pursuant to Commission on Ethics Ordinance Sec. 2-260.3(b), Dismissal of complaints, the complaint may be dismissed and a letter of instruction issued at this stage of the proceedings if the Commission finds that the violation was inadvertent, unintentional, or insubstantial.

After hearing statements from the COE advocate and the Respondent, the Commission determined that probable cause existed, issued a letter of instruction, and dismissed the case finding that the violation was inadvertent, unintentional, or insubstantial.

Therefore it is:

ORDERED AND ADJUDGED that the complaint against Respondent, Barbara King, is hereby DISMISSED and a Letter of Instruction is issued.
