
The Commission on Ethics

Dedicated to Ethical Excellence

The Palm Beach County Commission Ethics oversees, interprets, enforces, and provides guidance on the Palm Beach County Code of Ethics, which was established in 2011 with stringent ethics standards, authorized FL bv Statutes, §112.326. The Code of **Ethics** reminds government officials and employees that public service is a public trust, requiring impartiality and commitment to the best interests of Palm Beach County residents.

The Palm Beach County Commission on Ethics trains officials, employees, vendors, lobbyists, and community members on the requirements of the county's Code of Ethics; offers legal advice through advisory opinions; investigates alleged violations of the three local ethics ordinances; and enforces these rules as needed.

6 Big Ethics Reminders

Honesty in Applications for Positions Sec. 2-443(h)

person applying No for employment, appointment to an advisory board or seeking a contract with the county or a municipal government may make any false statement, submit any false document, or knowingly withhold information about wrongdoing with connection employment or application.

Travel Expenses Sec. 2-443(f)

No official or employee shall accept directly or indirectly, any travel expenses, including, but not limited to, transportation, lodging, meals, registration fees, and incidentals from any county or municipal contractor, vendor, service provider, bidder or proposer, as applicable.

Anti-Nepotism Sec. 2-445

An official may not appoint, employ, promote, advance, or advocate for appointment, employment, promotion, or advancement in or to a position in the county or municipality (as applicable) in which the official is serving or over which the official exercises jurisdiction or control, any individual who is a relative or domestic partner of the official.

Gift Law Sec. 2-444(a)(1)

No county commissioner, member of a local governing body, mayor or chief executive when not a member of a governing body, or employee, or any other person or business entity on his or her behalf, shall knowingly solicit or accept. directly or indirectly, any gift with a value of greater than on that hundred dollars (\$100) in the aggregate for the calendar year from any person or business entity that the recipient knows, or should know with the exercise of reasonable care, is a vendor, lobbyist, or any principal or employer of a lobbyist who lobbies, sells, or leases to the county or municipality as applicable.

Gift Law Sec. 2-444 (2)(b)

All employees who are not reporting individuals under state law and who receive any gift in excess of one hundred dollars (\$100)... shall complete and submit an annual gift disclosure report with the county commission on ethics no later than January 31 of each year for the previous calendar year (January 1 through December 31).

Post-Employment Ordinance Sec. 2-143

No former county commissioner shall knowingly represent anyone other than the county or another public entity in connection with any matter for a period of two (2) years after the cessation of his or her term of office with the county.

No former level 1 or level 2 employee shall knowingly represent anyone other than the county or another public entity in connection with any manner for a period of six (6) months after the cessation of his or her employment with the county.

Ethics guides how people should act in situations, weighing the effects of their choices and the potential consequences of their actions on themselves and their community.

Advisory Opinions

Requests for an Advisory Opinion are sent to the intake manager for processing.

The intake manager reviews the question to confirm it falls within the scope of the Code of Ethics. Once confirmed, the request is entered into our project tracking system, a file is created, and the matter is assigned to the general counsel.

The general counsel then reviews the request and determines what portion of the Code of Ethics applies to the information provided.

Written guidance is then drafted outlining what actions are permitted or not permitted under the Code without resulting in a violation.

The Advisory Opinion is then submitted to the Commission for its approval at its next public meeting. Once the opinion is approved by the Commission, it is published on our website, and a copy is provided to the individual who submitted the request.
